IN THE MATTER OF the *Pension Benefits Act*, R.S.O. 1990, c. P.8, as amended (the "Act"), in particular sections 87 and 89;

AND IN THE MATTER OF the Rules and Regulations of the LiUNA Pension Fund of Central and Eastern Canada, Registration Number 0573188 (the "Plan").

REFUSAL TO ORDER

On March 18, 2019, pursuant to section 89(5) of the Act, the Superintendent of Financial Services (the "Superintendent") issued a Notice of Intended Decision to refuse to make an order under section 87(1) of the Act, respecting the Plan.

Effective June 8, 2019, pursuant to the *Financial Services Regulatory Authority of Ontario Act, 2016*, S.O. 2016, c. 37, Sched. 8, the Financial Services Regulatory Authority of Ontario ("FSRA") became the regulator under the Act and the powers and duties previously vested in the Superintendent under the Act were vested in the Chief Executive Officer of FSRA (the "Chief Executive Officer").

A Request for Hearing (Form 1), dated June 5, 2019, was delivered to the Financial Services Tribunal (the "Tribunal") in accordance with section 89(6) of the Act respecting the Notice of Intended Decision.

On January 17, 2020, the applicant withdrew the Request for Hearing (Form 1) and the Tribunal closed its file in respect of this matter. Therefore, pursuant to section 87 of the Act, and by delegated authority from the Chief Executive Officer, the Head, Pension Plan Operations and Regulatory Effectiveness, makes the following decision.

REFUSAL TO ORDER

An Order to require the Administrator of the Plan to refund the application fee is hereby refused, for the reasons set out in the Notice of Intended Decision.
