NOTICE OF INTENDED DECISION

I INTEND TO MAKE AN ORDER under section 83 of the *PBA* declaring that the
Pension Benefits Guarantee Fund (the "Guarantee Fund") applies to the Nortel Networks
Negotiated Pension Plan, Registration Number 0587766 (the "Plan").

REASONS:

1. The Plan is registered under the *PBA*.
2. The Plan provides defined benefits that are not exempt from the application of the
Guarantee Fund by the *PBA* or the regulations made thereunder.
3. The Plan is being wound up effective October 1, 2010.
4. There are reasonable and probable grounds that the funding requirements of the *PBA* and
regulations cannot be satisfied. In an Actuarial Opinion prepared by the Plan's Actuaries
dated March 31, 2011 and filed by the Administrator, the Plan's Actuaries attest that the

Plan's assets are not sufficient to cover the liabilities of the Plan on a wind up basis. They also attest that the Ontario assets of the Plan are significantly less than its Ontario wind up liability. They recommend that the Administrator apply for an allocation from the Guarantee Fund for the payment of benefits guaranteed by the Guarantee Fund.

5. Such further and other reasons as may come to my attention.

YOU ARE ENTITLED TO A HEARING by the Financial Services Tribunal (the "Tribunal") pursuant to section 89(6) of the *PBA*. **To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Intended Decision is served on you.**¹
