## NOTICE OF PROPOSAL

**I PROPOSE TO MAKE AN ORDER** under section 69 of the *PBA Pension Plan for the Employees of R.C. Fire Protection Ltd.* (the “Plan”) be wound up effective **December 31, 2008.**

### **REASONS:**

**There was a cessation or suspension of employer contributions to the pension fund.**

**Failure of employer to make contributions to the pension fund as required by the Act or the Regulations;**

**All or a significant portion of the business carried on by the employer at a specific location was discontinued.**

**Such further and other reasons as may come to my attention.**

**YOU ARE ENTITLED TO A HEARING** by the Financial Services Tribunal (the “Tribunal”) pursuant to section 89(6) of the *PBA*. **To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Proposal is served on you.**<sup>1</sup>
