### **NOTICE OF PROPOSAL**

**I PROPOSE TO MAKE AN ORDER** under section 78(4) of the *PBA*, consenting to the  
payment out of the Plan to **Mosaic Esterhazy Holdings Limited**, as at October 21, 2009 in the  
amount of **\$18,144.28** plus interest to the date of payment.

#### **REASONS:**

1. **Mosaic Esterhazy Holdings Limited** is the employer as defined in the Plan.
2. **As a result of the final distribution process of the wind-up benefits to the Plan members, a final lump sum contribution of \$282,011.00 was made to the plan in October 2009. After all benefits have been settled, an amount of \$18,144.28 remains in the fund.**
