**NOTICE OF PROPOSAL**

**I PROPOSE TO MAKE AN ORDER** under section 69 of the *PBA* that Employees Pension Plan North American Life Policy No Gs-p33211. (the "*Plan*") be wound up effective June 1, 2008.
